- 01. The quotation fee of Rs. 300.00 (Rupees Three Hundred) only in the form of Demand Draft to be drawn in favour of DIRECTOR OF RESEARCH (VETERINARY) payable at SBI, Khanapara Branch is not refundable. If the quotation documents are downloaded from the website, the quotation fee in the form of DD must be submitted along with the quotation, without which the quotation will be rejected.
- 02. The bidder shall enclose the Earnest Money Deposit (EMD)of Rs. 15,000.00 (Rupees Fifteen Thousand) only in the form of DD drawn in favour of the DIRECTOR OF RESEARCH (VETERINARY), payable at SBI, Khanapara Branch. The bids that are not accompanied by the aforesaid bid security will not be accepted. The details of bid security must be provided in the cover letter. The bid security of the unsuccessful bidders will be released after issuing supply order to the successful bidder and the bid security of the successful bidder will be released after execution of the order.

It will be the discretion of the AAU authority to extend the validity of the approved rate(s) for further period(s) subject to agreement of the supplier to supply the items at the approved rate(s) during such extended period.
- 05. Quotation must also be submitted in a soft copy in CD (to support in Microsoft words only) in the following format failing which the bid will be treated as non-responsive, at the discretions of the purchaser. Any discrepancies in the soft copy will be the responsibility of the bidder.

- 06. Bidders must supply the items at their own cost at AAU, Khanapara.
- 07. The Bidder must submit the test report of nutrient composition of the feed to be supplied from a reputed laboratory along with the quotation.
- 08. The rate shall be quoted for all duties, taxes and other levies payable by the bidder shall be included in the item rate. GST should be quoted separately (GST No. must be furnished)
- 09. There should not be any overwriting. Corrections, if any, should be made with dated initial of the bidder.
- 10. Rates should be quoted clearly both in words and figures separately for each item without which the quotation shall stand rejected.
- 11. Detailed specification of the feed and the name of manufacturer along withuser list including contact number of the users should be furnished.
- 12. Attested copies of Dealership Certificate must be enclosed along with the quotation.
- 13. The price quoted shall be fixed and not subject to adjustment/variation during the performance of the contract.
- 14. Up-to-date Sale Tax clearance certificate and Income Tax return of last three years duly attested must be submitted along with the quotation. PAN No. must befurnished
- 15. Delivery has to be completed within 10 (Ten) days from the date of issuing supply order.
