- 4. Eligibility: A Bidder-
  - (a) Shall not participate in more than one Quotation;
  - (b) Shall not have conflict of interest as defined in the State Govt's Procurement Regulations; and
  - (c) Should not have been
    - (i) Temporarily suspended or debarred by AAU or any other Govt. organization in compliance with the State Govt's anti-Corruption Guidelines; or
    - (ii) Blacklisted or suspended by, AAU, Central or any State Government Departments in
  - India.

- 8.Contract may be awarded to the Agency having submitted a quotation representing the best value for money, i.e. lowest-priced technically-compliant of the proposed offers.

#### 9. The Quotation shall comprise the following documents:

- a) Name, address, e-mail, telephone along with a note on the ownership and organizational structure & core business area of the firm;
- b) Document (s) to demonstrate that the agency is in the business for the last **5** years.
- c) Document (s) relating to details of similar nature of services executed during the last 5 years with State/Central Governments/PSUs/reputed private organizations, supported by Work Orders etc.;

- d) IT returns of the last **3** financial years.
- e) GST Registration Certificate and returns of the last 3 financial year.
- f) Have in-house expertise on the vehicle rentals and management including necessary infrastructure facilities.
- g) The qualified bidder may have to sign a contract agreement with the Director of Research (Vety), AAU, Khanapara on N.J. stamp paper of Rs 100 as per approved terms and conditions.

  - d) Quotation received after due date and time will not be considered and the office shall not be liable or responsible for any postal delays.
  - e) Quotation shall be signed by the Bidder or a person duly authorized by the Bidder. All pages of the bid shall be signed and stamped by the authorized person to indicate that the bidder has agreed to all terms and conditions of the quotation. Overwriting, alterations, if any, in the Quotation should be signed by the authorized signatory.
  - f) Quotation not accompanied by specified documents, self declarations, signatures may be rejected by the office as non-responsive and may not be evaluated.
  - g) All duties, taxes and other levies payable by the bidder under the contract shall be shown separately and included in the Total price.

#### 12. Evaluation of Quotation:

- a) The Director of Research (Vety), Assam Agricultural University, Khanapara, Guwahati shall evaluate and compare the Quotations determined to be substantially responsive, i.e. which,
  - i. Are properly signed and sealed;

- ii. Have submitted the required documents and meet the criteria specified;
- b) The quotation that complies with all of the specifications, requirements and offers the lowest price, as well as all other evaluation criteria indicated, shall be selected. Any offer that does not meet the requirements shall be rejected.

#### 13. Award of contract:

- a) The Director of Research (Vety), Assam Agricultural University, Khanapara, Guwahati will award the contract to the bidder/agency whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
- b) Notwithstanding the above, the AAU reserves the right to accept or reject any quotation and to cancel the bidding process and reject all quotations at any time prior to the award of the contract.
- c) The bidder whose quotation is accepted will be notified of the award of the contract by the Director of Research (Vety), Assam Agricultural University, Khanapara, Guwahati prior to the expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the order.

#### 14. Performance Security:

- a) Within 7 days of receiving letter of acceptance, the successful bidder shall submit the Performance Security in the form of Deman Draft from any Nationalised Bank, drawn in favour of "Director of Research (Vety), Assam Agricultural University, Khanapara, Guwahati-781022" for an amount of Rs 20,000( Rupees Twenty Thousand Only) payable at SBI, Khanapara (9945)
- b) The Performance Security furnished by the successful bidder will be retained by the AAU up to 6 months of continued vehicle rental services. On satisfactory performance of the agency during the period, the performance security shall be returned to the successful bidder. However, the Performance Security instrument held by the office till it is returned to the successful bidder will not earn any interest. Failure of the successful bidder to furnish Performance Security within the stipulated period shall constitute sufficient ground for annulment of award and the Director of Research (Vety), AAU may award the contract to the next eligible bidder.
